India's Duty Free Tariff Preference (DFTP Scheme for least Developed Countries (LDC)

One of the elements of the Hong-Kong Ministerial Declaration of December 2015 was to extend Duty Free quota Free (DFQF) access to the exports of Least Developed Countries (LDCs).

DFTP scheme of 2008

India became the first developing country to extend this facility to Least Developed Countries (LDCs). India announced the Duty Free Tariff Preference (DFTP) Scheme for LDCs in year 2008. The scheme was announced to give support to the LDCs in their trade initiatives. Under the scheme, by 2012, 85% of India's total tariff lines were made duty free, 9% tariff lines enjoying a margin of Preference (MOP) ranging from 10% to 100% and only 6% of total tariff lines retained in Exclusion List with no duty preferences, for the exports from LDCs.

At present, 31 LDCs have become beneficiaries to the scheme. These countries include the following :
